Licensee and Authorized Users shall be able to access the Licensor’s online journal content that is included in the selected Digital Archive product(s), from Authorized Sites only, for as long as Licensee continues to pay the Licensor’s Digital Archive annual fee. The base price for the annual fee shall be \$395. Licensor reserves the right to increase the annual fee one year after the purchase of the Digital Archive product(s) but guarantees that it shall not be greater than five percent (5%) in any given year. The annual fee for any given year will be waived for that year provided that Licensee maintains at least one institutional subscription to an Optica Publishing Group journal (excluding *Optics & Photonics News*) in that year.
- iv. The contents of the selected Digital Archive products constitute the complete content licensed under this Addendum and are not to be confused with the “Licensed Materials” under the 2017 License Agreement if different.

The Terms and Conditions of the 2017 License Agreement shall apply to Licensee’s access to and use of the content in the selected Digital Archive product(s). To the extent that the terms of this Addendum are inconsistent with those of the 2017 License Agreement, this Addendum governs Licensee’s access to the selected Digital Archive product(s) and the use of its contents.
